ANY CITIZEN IN THE UNITED STATES WHO IS AT LEAST TWENTY-ONE (21) YEARS OF AGE AND WHO, FOR THE PERIOD OF AT LEAST FIFTEEN (15) YEARS IMMEDIATELY PRECEDING ELECTION TO OFFICE, HAS NOT BEEN CONVICTED OF A CRIME INVOLVING MORAL TURPITUDE OR A CRIME WHICH WOULD BE A FELONY IF COMMITTED IN DELAWARE, AND WHO HAS RESIDED OR OWNED REAL PROPERTY IN THE TOWN FOR AT LEAST ONE (1) YEAR PRIOR TO ELECTION, SHALL BE ELIGIBLE TO HOLD THE OFFICE OF COUNCIL MEMBER.
