Re: Filing Fees for Candidates

On January 20, 2014, at a regularly scheduled meeting of the Democratic Party of Kent County Executive Committee, a motion was passed, in accordance with 15 *Del. C.* § 3103 (a) (2), which established the candidate filing fee at 1% of the total salary for the entire term of office as provided for by 15 *Del. C.* § 3103 (b) for the following offices. They are:

State Senator	$\$44,041 \times 4 \text{ years} = \$176,164 \times .01 \text{ percent} = \$1,761.64$
State Representative	$\$44,041 \times 2 \text{ years} = \$88,082 \times .01 \text{ percent} = \$880.82$
Recorder of Deeds	$\$30,417 \times 4 \text{ years} = \$121,668 \times .01 \text{ percent} = \$1,216.68$
Sheriff	$\$30,417 \times 4 \text{ years} = \$121,668 \times .01 \text{ percent} = \$1,216.68$
Levy Court Commissioner	$\$30,417 \times 4 \text{ years} = \$121,668 \times .01 \text{ percent} = \$1,216.68$


