Candidate Filing Instructions

In response to the current State of Emergency, the Department of Elections – Kent County Office has established the following procedures for candidates who want to file their candidacy.

For those who choose to come to our office, we have limited the number of visitors to our office to 1 person at a time and expect visitors to respect the 6-foot Social Distancing Standard to limit the exposure of our staff to COVID-19.

Our “Candidate Filing Page” has links to forms and information. The Kent County Office can only accept filings for districts within Kent County. The candidates for all other offices must file with the State Election Commissioner’s Office.

1. Do the filing by mail – we suggest you use a trackable form of mail:

- a. Complete the Candidate Filing Form, sign the form in front of a Notary.
- b. You must use your full legal name when completing the form – no nicknames. If you have a question regarding how your name will appear on the ballot contact this office.
- c. Write a check for the filing fee payable to the correct party entity. The filing fees are at: <https://elections.delaware.gov/services/candidate/filingfees.shtml>.
 - i. Democratic candidates make the checks payable to – **Kent County Democratic Committee.**
 - ii. Republican candidates make the checks payable to – **Kent County Republican Committee.**
- d. Make a copy of your Driver’s License or State ID Card.
- e. Mail the completed Candidate Filing Form, the check, and the copy of your Drivers License or State ID Card to:

- f. Someone from the office will call you once we receive the form.

2. Complete the filing in the office:

- a. Bring a completed but unsigned form, completed check, and your Drivers License or State ID card to the office.
- b. Do not bring anyone else. We only permit one visitor at a time in the office.

Complete and sign the form requesting candidate data if you want that information https://elections.delaware.gov/pubs/statewide_vreg_cd_order_form.pdf. The data for districted offices can most likely be emailed. Countywide data must be sent by CD. If you want a CD, it must be mailed to you. Email the completed request for candidate data to votekc@delaware.gov.
